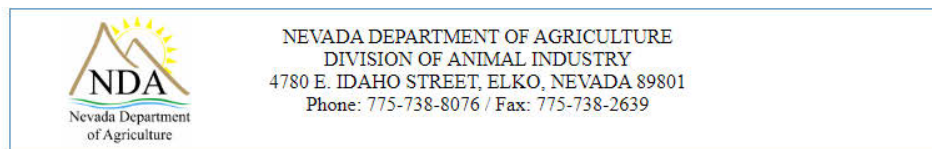
Below are **step-by-step instructions** on how to login and enter information into the Nevada Department of Agriculture's (NDA) online Brand Re-recording system.

1. Access the website

- a. Open your web browser and type <https://nv.certifyag.com/Renew/> in or [click here](#).

2. Log In

- a. To log in to the system you must have your brand number and renewal access code.
- b. Enter your brand number and your renewal access code as they appear on your renewal letter and click on the "Renew Brand" button.

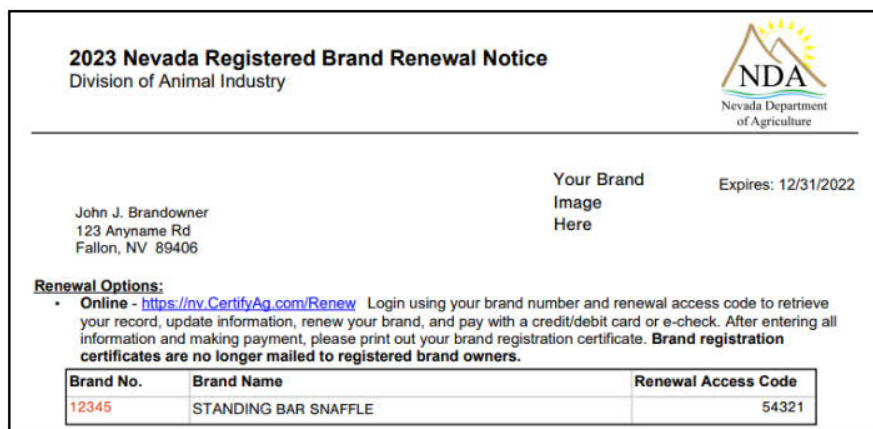

Enter your Brand No. and Renewal Access Code, and click "Renew Brand" to begin the renewal process:

As per Nevada Revised Statute 564.120, all Nevada livestock brands must be re-recorded at the end of each 4-year period. All brands not renewed by December 31, 2022, will expire. They will be lost to record January 1, 2024.

Our online renewal system accepts e-Checks, American Express, Visa, MasterCard, and Discover.

When renewal transaction is complete, you will have the option to print your receipt, brand certificate, and/or wallet card.

- b. To pay via a credit card, enter the following required information:
 - i. Card number
 - ii. Security code
 - iii. Expiration date (month and year)
 - iv. Card type (select from drop down)
 - v. Billing first and last name
 - vi. Billing address
 - vii. City, state, zip
- c. To pay via eCheck (an electronic version of a paper check, which can be used by anyone with a checking account) enter the following required information:
 - i. Select checking or savings
 - ii. Bank routing number
 - iii. Account number
 - iv. Billing first and last name
 - v. Billing address
 - vi. City, state, zip
